I have considered Plaintiffs' Application for Temporary Injunction, response, replies evidence, and arguments of counsel and hereby GRANT-IN-PART and DENY-IN-PART the Application. While the Court does not reach the merits of the Plaintiffs' claims, it does find that Plaintiffs have demonstrated a probable right to relief sufficient to warrant the issuance of a temporary injunction in this matter. Therefore, the Application is granted as to the previous injunctions in the Court's Temporary Restraining Order and is denied as to any request for injunction beyond what was restrained in the Court's Temporary Restraining Order. The Temporary Injunction is effective until final trial on this matter, which shall be set on February 1, 2021.
